## 1. Services Provided

SleepySeat Cleaners ("Service Provider") agrees to provide the following services to the Client:

- Cleaning of infant, toddler, and/or booster car seats using baby-safe, non-toxic products.
- Surface sanitation, spot removal, and deodorizing of fabric and plastic parts.
- Disassembly of removable components, if required, for cleaning.
- Reassembly of the car seat based on standard manufacturer guidelines (not to be interpreted as installation into a vehicle).

## 2. Pickup and Return

The Service Provider will pick up and return the car seat(s) as scheduled by the Client.

Seats will be returned fully cleaned and reassembled, but not reinstalled in the vehicle.

## 3. Client Responsibility for Installation

By signing this agreement, the Client acknowledges and agrees that:

- The Service Provider is not responsible for reinstalling the car seat in the Client's vehicle.
- The Client is solely responsible for ensuring that the car seat is correctly and safely installed in accordance with the manufacturer's guidelines and local safety laws.
- Improper installation can result in serious injury or death. Clients are strongly encouraged to consult certified child passenger safety technicians (CPSTs) for proper installation.

## 4. Liability Waiver

The Client agrees that the Service Provider shall not be held liable for any injuries, damages, or incidents that result from improper use, reinstallation, or installation of the cleaned car seat.

The Service Provider assumes no liability for any loss or damage incurred after the seat is returned to the Client.

## 5. Damage Disclaimer

While reasonable care is taken to preserve all parts of the car seat during cleaning, the Service Provider is not responsible for:

- Pre-existing damage
- Wear and tear
- Loose or deteriorated parts
- Labels, decals, or instructional materials that may come loose during cleaning
